## **TERMS AND CONDITIONS**

- 1 Validity: As noted on the quotation.
- 2 Currency: We reserve the right to vary the quotation without prior notification if the currency exchange rate varies more that 2% based on the published exchange rates of the Reserve Bank of Australia from the date of quotation. Contact the issuer of the quotation to confirm the exchange rate used.
- 3 Proposed Delivery Schedule:

Pipes to be despatched from accordance to an agreed delivery schedule.

- 4 The above price includes delivery to site.
- 5 The above price includes:
  - a. Collar
  - b. Lubrication ports every 5th pipe (3)
  - c. Loading & Lashing of pipes into 20" or 40' containers (when applicable)
  - d. AQIS & Customs charges
- 6 The above price excludes:
  - a. Access road and site preparation for pipe delivery at job site
  - b. Unloading container or truck at job site
  - c. Pipes used for testing and compliance purposes.
- 7 Third Party Inspector

There is an additional charge in case a third party inspector is required.

8 Container Deliveries

Pipes are delivered in 20" or 40" shipping containers to site using a side loader. It is the customer's responsibility to decant the container in a safe, level and all weather area without damage to the pipes or container. The customer is to decant the container within 3 days of delivery to site and arrange collection of the container. The container must be broom cleaned and presentable.

9 Break Bulk / Flatbed Deliveries

Pipes are delivered on a flatbed truck. It is the customer's responsibility to unload the truck in a safe, level and all weather area without damage to the pipes or truck. The customer is to unload the truck within 30 minutes of its arrrival to site.

**10** Additional freight charges, if applicable, as follows:

The quote allows for 30 minutes on site to unload the truck and/or container at site. If longer than 30 minutes is required, demurrage is charged at A\$150.00 per hour or part thereof.

If the customer is not in a position to accept the scheduled delivery and the container needs to be staged off site prior to delivery to site, then the following charges will be applicable:

a. Redirection Fee
b. Fuel Surcharge 23%
c. Lift On/Lift Off
A \$275.00 per container
A \$57.50 on cartage cost
A \$102.00 per container

d. Storage Charge A \$153.00 per day, per container

Additional break bulk freight charges, if applicable, as follows:

a. Detention at the wharf after 1hr: AUD \$95.00 per hour or part thereof b. Detention at Site after 1hr: AUD \$95.00 per hour or part thereof

## 11 TERMS OF PAYMENT

- a. 30% Advance Payment via bank transfer upon signing of contract or receipt of Purchase Order
- b. Advance payment is unsecured and non-refunable unless agreed prior between parties in writing le. No allowances have been made for the issuing of a Bank Guarantee against any payment received
- c. 70% Payment within 14 days of receipt and issue of the Bill of Lading to the Customer.
